CORRECTED ORDINANCE NO. 2, 1977

**COPY**

AN ORDINANCE ANNEXING CERTAIN CONTIGUOUS REAL ESTATE TO THE TOWN OF ROANN.

Be it hereby ordained by The Town Board of Trustees of The Town of Roann, Indiana, that certain described real estate is here-

by annexed and made a part of the corporate real estate included within the Town of Roann, all in Wabash County, Indiana, to-wit:

A part of Section One (1), Township Twenty-eight (28) North, Range five (5) East, more particularly bounded and described as follows, to-wit:

Beginning at the intersection of the center of Quincy Street and the east line of the Fairfield Addition to the Town of Roann, thence east 320 feet along the center of Quincy Street Extended; thence south on a line parallel with the east line of the Fairfield Addition 174 feet; thence west 320 feet along a line parallel with the center of Quincy Street Extended to the east line of the Fairfield Addition; thence north 174 feet along the east line of Fairfield Addition to the place of beginning.

This ordinance shall be in full force and effect from and after its passage and publication as may be required by law.

This ordinance is a correcting ordinance for Ordinance No. 2, 1977, dated the 10th day of October, 1977, recorded on the 11th day of October, 1977 in Miscellaneous Record 48 page 162 in the office of the Recorder of Wabash County, Indiana, deleting two tracts of real estate consisting of 4.62 acres, more or less, and 2.01 acres, more or less, in the fractional northeast quarter of Section 2, in Township 28 North, Range 5 East in Wabash County, Indiana, which two tracts of real estate are not annexed to the Town of Roann.

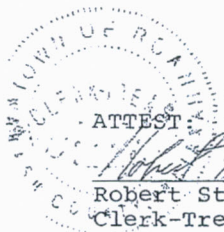
