

SPECIAL ORDINANCE NO. 1, 1990
 AN ORDINANCE OF THE TOWN OF ROANN,
 INDIANA FIXING THE SALARIES OF THE
 TOWN CLERK, TOWN BOARD OF TRUSTEES,
 TOWN EMPLOYEES AND OTHER TOWN OFFICIALS.

Whereas it is the responsibility of the Town Board of Trustees of the Town of Roann to fix salaries of the Town Board of Trustees, the Town Clerk-Treasurer, the Town employees by Ordinance and other Town officials performing Town duties pursuant to the provisions of the Acts of 1905, Chapter 129;

Now, therefore, be it ordained by the Town Board of Trustees of the Town of Roann, Indiana that the salaries of the Town officials designated below, beginning January 1, 1991 and continuing thereafter until duly changed, shall be as follows:

Whereas it is the desire of the Board of Trustees of the Town of Roann, Indiana to have both a Clerk-Treasurer and a Deputy Clerk-Treasurer in order to have two residents with a working knowledge of the Clerk-Treasurer position to effect an orderly transition in the event of a Clerk-Treasurer's resignation; now, therefore, be it ordained that the salaries of said positions as to General Fund expenditures are fixed as above. Realizing, however, that at times the Deputy Clerk-Treasurer's position may be vacant and/or unfilled, the Board of Trustees does furthermore ordain that should said position be vacant and the Clerk-Treasurer be responsible for performing the Deputy's water and sewage utility duties until such time as a suitable Deputy is working, then the Clerk-Treasurer shall receive as additional salary the salary designated for the Deputy from the water and sewage funds at the rate of \$100 per month during the time the Clerk-Treasurer performs the duties of both positions.

This Ordinance shall be in force and effect from and after its passage by The Board of Trustees of the Town of Roann, Indiana as provided by the Laws and Statutes of the State of Indiana.
