

**SPECIAL ORDINANCE NO. 1, 2011  
 AN ORDINANCE OF THE TOWN OF ROANN, INDIANA  
 FIXING THE SALARIES OF THE TOWN CLERK, TOWN BOARD OF  
 TRUSTEES, TOWN EMPLOYEES AND OTHER TOWN OFFICIALS.**

WHEREAS, it is the responsibility of the town Board of Trustees of the Town of Roann to fix salaries of the Town Board of Trustees, the Town Clerk-Treasurer, the Town Employees by ordinance and the Town Officials performing Town duties pursuant to the provisions of the Acts of 1905, Chapter 129:

NOW, therefore, be it ordained by the Town Board of Trustees of the Town of Roann, Indiana that the salaries of the Town officials designated below, beginning January 1, 2011 and continuing thereafter until duly changed, shall be as follows.


