



AN ORDINANCE OF THE TOWN OF ROANN, INDIANA,
 DETERMINING TO APPROPRIATE AND EXPEND ADDI-
 TIONAL AMOUNT TO MEET AN EXISTING EMERGENCY.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF ROANN,
 INDIANA, That:

WHEREAS, The Board deems it that an emergency exists for the
 transfer, appropriation and expenditure of funds not included in
 the approved and adopted budget for the year 1967; and,

WHEREAS, notice has been given as required by law to the
 Taxpayers of said corporation that a hearing would be held on
 said additional appropriation at 7:00 o'clock P.M. (EST) on the
 7th day of September, 1967; and

WHEREAS, a hearing has been held on said additional appro-
 priation for the receipt of objections thereto and no objections
 have been received.
