

SPECIAL ORDINANCE NO. 1, 2020
AN ORDINANCE OF THE TOWN OF ROANN, INDIANA
FIXING THE SALARIES OF THE TOWN CLERK, TOWN BOARD OF
TRUSTEES, TOWN EMPLOYEES AND OTHER TOWN OFFICIALS.

WHEREAS, it is the responsibility of the Town Board of Trustees of the Town of Roann to fix salaries of the Town Board of Trustees, the Town Clerk-Treasurer, the Town Employees by ordinance and the Town Officials performing Town duties pursuant to the provisions of the Acts of 1905, Chapter 129.

NOW, therefore, be it ordained by the Town Board of Trustees of the Town of Roann, Indiana that the salaries of the Town officials designated below, beginning January 1, 2019 and continuing thereafter until duly changed, shall be as follows.

WHEREAS, it is the desire of the Board of Trustees of the Town of Roann, Indiana to have both a Clerk-Treasurer and a Deputy-Clerk-Treasurer in order to have two residents with a working knowledge of the Clerk-Treasurer position to effect an orderly transition in the event of a Clerk-Treasurer's resignation.

FURTHERMORE, to maintain flexibility in the Utility Organization there are (2) two programs that may be used by the Board of Trustees of the Town of Roann, Indiana. These shall not run simultaneously and may be changed at any time the Board of Trustees deem it necessary: now, therefore, be it ordained that the salaries of said positions as to General Fund expenditures are fixed as above. This ordinance shall be in force and effect from and after its passage by the Board of Trustees of the Town of Roann, Indiana as provided by the Laws and Statutes of the State of Indiana.


